I object to HKR application for rezoning and development of area 10B in its current form.

The reclamation at Nim Shue Wan is of particular concern (with effects on marine life and loss of local water sport recreation area, yacht moorings, etc) and appears to be based on dubious authority.

HKR have already back-peddled and now claim that Plan 11317 dated 21 Feb, 1978, gives it the required authority. P11317 was gazetted on 10 March, 1978 for the purpose of providing a ferry pier and a submarine outfall, not for the purpose of reclamation at Nim Shue Wan.

In further support of its contention that the reclamation has already been gazetted, HKR has provided a plan showing the extent of the "approved" reclamation. Yet this plan states that the reclamation was gazetted in 1977, not in 1976 or in 1978.

The company is not providing a consistent story and should produce P11317 and any relevant supporting documentation to confirm the right to reclaim the seabed at Nim Shue Wan up to the boundary shown in New Grant 6788.

I object to HKR application for rezoning and development of area 10b in its present form.

I am particularly concerned that the population cap of 25,000 (10,000 residential units assuming 2.5 residents/unit) may be breached with consequent ramifications for water, sewerage and transport services. A population of 25,000 is the cap under the OZP and crucially it is the cap under the water supply agreement with the Water Supplies Department (WSD). At the planning ratio of 2.5 persons per unit, this means that the maximum number of flats that can receive government water is 10,000.

There are presently 8,326 flats in DB. However, the latest Master Plan, MP 6.0E7h(a), has approved an increase to 8,735. HKR points to MP 6.0E7h(a) to have us believe that adding an extra 1,601 flats is reasonable. However, this conveniently ignores the fact that the existing OZP already allows significantly more development than shown on the current Master Plan.

New development of 124,000 sq metres at DB North (currently being reviewed by the Lands Dept), is likely to produce 2,240 flats. This alone will bring DB's total well above 10,000 flats. The 1,601 flats from 6f and 10b must then be added on top. What then happens about the water supply? We can easily see why it is in HKR's interest to understate the population in DB, as it did in its initial submission and as it continues to do by floating persons-per-unit ratios of 2.35 and 2.2.

There is a clear need to have a comprehensive view of future development in DB, in order to set out the full infrastructure needs accordingly. Any increase beyond the current approved population limit of 25,000 must be fully justified and supported with proper engineering and impact studies.

Further to my previous comments, I find it ridiculous that HKR submitted another application without resolving the issue that we brought out last time; in particular the potable water.

I have summarized my comments below:-

1. The current proposal, together with Y/I-DB2 deviate from the sustainable living style that we were led to believe by HKR when we committed to purchase properties in Discovery Bay ("D B"). Cases in points are when these development projects are completed, there will be:- (i) increased population by almost 10,000 (over 45% increase), (ii) potable water, sewerage, traffic will be beyond the current maximum capacities, (iii) level of visitors.
2. Discovery Bay is monopolistically managed by HKR with very opaque management and regulation. This is fundamentally against the Competition Law as well as Consumers Rights. The current connected and intertwined relationship with HKR and the City Management demands investigations for right an proper services and charges to the local DB residents.
3. As a chartered Chemical and Gas engineer, I am very concerned about the potential hazards with the current design related to fuel storage and transportation.

Given the above three points, I demand: 1. A proper and fair consultation involving a wider representation of the local residents and also the consultants that HKR hired to do their EPA and other assessments. 2. A scale-down version of the proposal be submitted as an alternative. 3. Delay all progress until further decision.

There were over 4,000 comments submitted to TPB in the previous round of consultation and many of the comments were not addressed by the applicant in this second round, mostly logistical issues having to do with the population cap of 25,000, sewage overload, non alignment of OZP and Master Plan, TIA not addressing safety issues with increased traffic for 4,000 new residents.

I know developers know how to package and re-package their proposals to TPB, with public comments diminishing at each round because people have already made their comments once. This should NOT diminish the importance of those comments made in the first round. TPB should make sure that these pertinent issues be addressed in subsequent rounds.

TPB should not rubber stamp approve this application simply because this is the second round already. This application should be withdrawn until HKR can adequately address these issues put forth by its residents.

Discovery Bay is unlike other developments in HK. It is a tiny city in itself and a tightly knit community. The developer HKR has a responsibility to uphold the "green environment" and low density living concept that they have been selling all along. It is not being turned into a mini Tung Chung and that is UNACCEPTABLE!

I object HKR application for the rezoning and proposed development of area 10b.

Lets talk about provision of sewerage service. HKR have not proposed a workable, viable answer to supply sewerage service to the new development. This subject alone should be enough to refute their application.

The Environmental Protection Department have made it very clear that for further development, HKR must provide its own sewage treatment facilities to meet the WPCO standards before discharge into the receiving waters. Use of the Siu Ho Wan Sewage Treatment Works (SHWSTW) is not an option.

In its latest submission to the TPB, HKR has acknowledged that that untreated sewage cannot be routed to the SHWSTW but in a letter circulated to all DB residents on 23 April, 2016, titled "Further Elaborations on DB Latest Development Plans", HKR was still making the misleading claim that sewage could be treated at the SHWSTW. No wonder the residents of DB have no trust in HKR. HKR are deliberately circulating inaccurate information.

To the TPB, HKR says "The applicant will undertake the design, construction and implementation of an on-site sewage treatment plant (STP) adequate for proper treatment of the sewage arising to meeting the permissible effluent standards for discharging into the receiving waters. ... Other detailed design parameter such as the treatment level, treatment technology, discharge location, effluent standards will be properly addressed at detail design stage subsequent to the approval of this rezoning application."

There is no detail on where and how the sewage will be treated, or where it will be discharged into the waters around DB. There is no clear, definitive information on who will pay for what for the maintenance of the whole sewerage system - plant, pipelines, marine outfall, etc.

HKR cannot be allowed to proceed with this application without a detailed, forward looking plan for sewerage treatment and disposal in Discovery Bay. The whole situation is totally unacceptable.

Indeed, there is NO OTHER PLACE ON ALL OF LANTAU TO PERFORM WORK ON BOATS, particularly sailboats, which cannot be hauled out anywhere nearby (including Cheung Chau and Aberdeen, where private facilities routinely refuse to work on sailboats due to their masts and keel configurations). The applicants should be required to provide a new vessel service area nearby before this application is allowed to proceed.

Furthermore, the development is likely to lead to removal of existing vessel moorings nearby, which would exacerbate an extremely severe shortage of moorings, including in the South Lantau area where there are NO OTHER MOORINGS anywhere. The applicants should be required to provide additional mooring space, available to the public on fair terms at low cost, before this application is allowed to proceed.

Additionally, the development will place additional stress on an already stressed environment. The authorities have failed to account for the cumulative effects of development on the quality of life and environment. The applicant should be required to promise no further development or additional housing for at least some decades before this application is allowed to proceed.

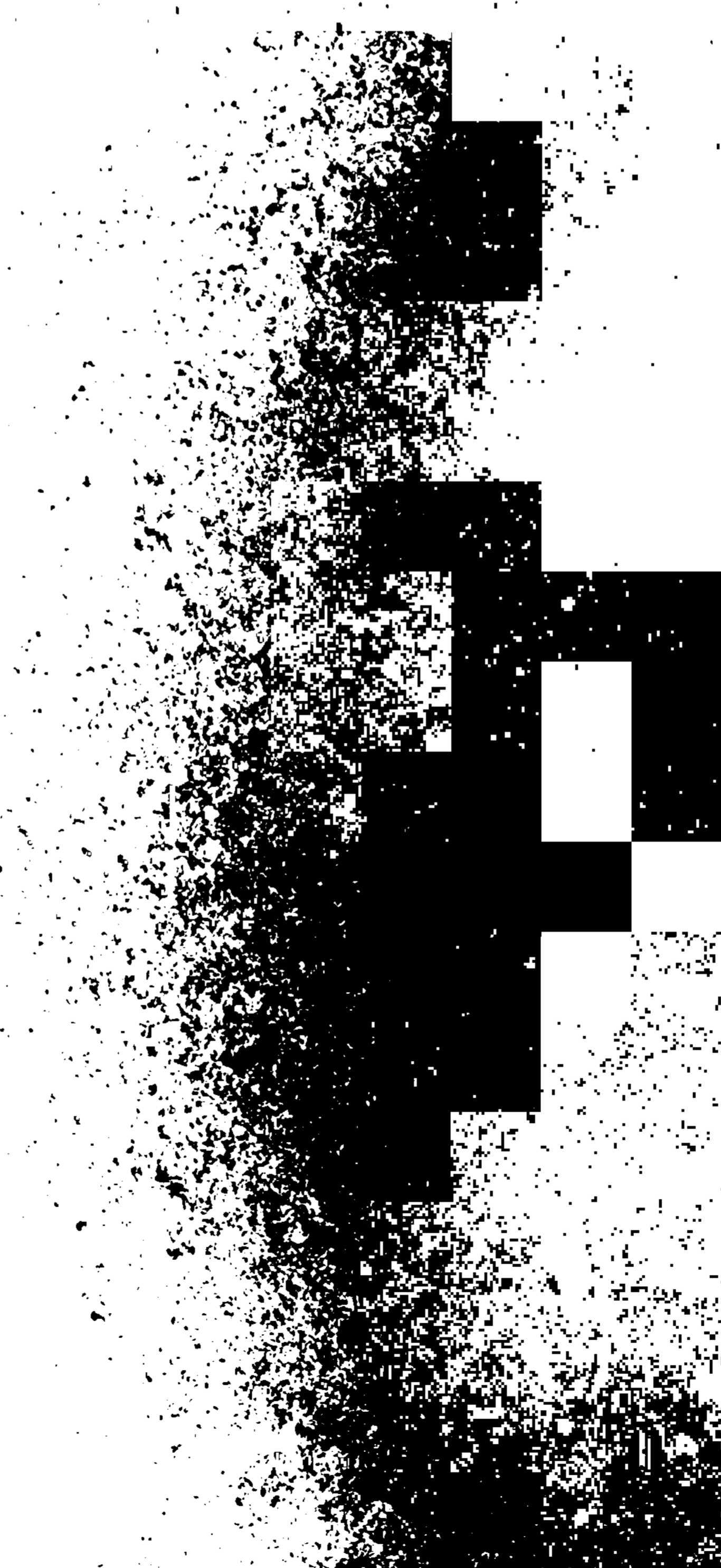

These Applications seek to increase that number to 29,000 which will be unsustainable without huge additional infrastructure and operational costs, much of which will have to be borne by existing residents. The population cap of 25,000 should be preserved, so as not to breach the Land Grant.

(2) The Application states that HKR is the sole owner of the Lot, which is untrue. There are presently over 8,300 assignees who co-own the Lot together with Hong Kong Resorts. HKR should withdraw the Application and make revisions to recognize the co-owners.

(3) The Master Plan forms part of the Land Grant at Discovery Bay, yet the current Master Plan (6.0E1) and the current OZP are not aligned. The Master Plan and OZP should be updated to ensure they are properly aligned, before considering any amendments to the OZP.

(4) The Schedule of Uses for the Promenade at Area 10b states that "This zone is intended primarily for the provision of outdoor open-air space... serving the needs of the local residents and visitors." Under the Deed of Mutual Covenant, there is no provision to allow public access to the Lot, nor is there any requirement for the residential owners to pay for the maintenance of public areas. Since public access is only allowed if an area is declared to be for Public Recreation on the Master Plan, this reference to 'visitors' should be removed or the Master Plan will need to be revised, with HKR undertaking the cost of management & maintenance of public areas.

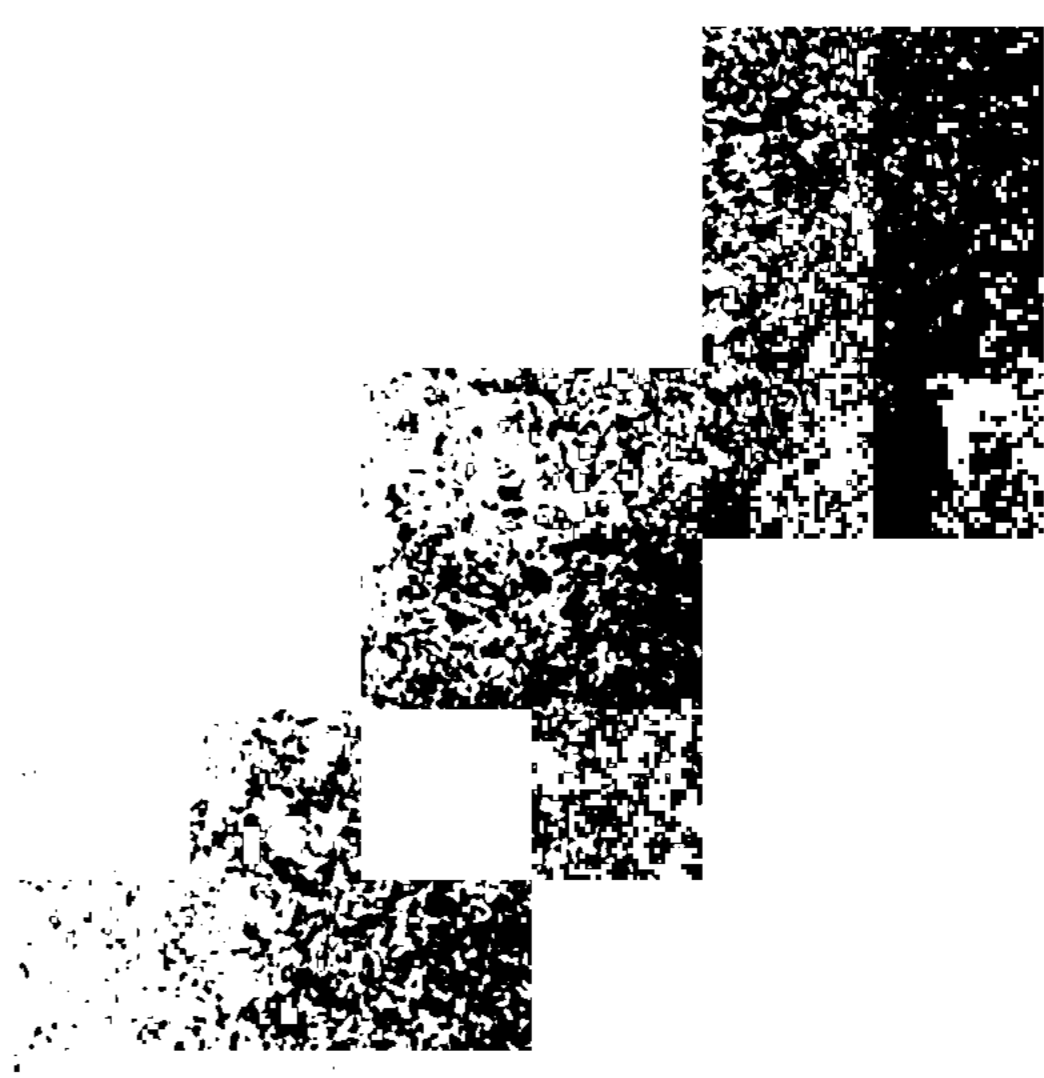
